



CHILDREN AGED 0-17 YRS IN OUT-OF-HOME-CARE





THE NEED FOR CHANGE IN AUSTRALIA ▼

Australia: expenditure on child protection, out-of-home care, intensive family support & family support services, 2011-12 to 2015-16 (\$billions)



- A record **\$4.8 billion price tag** of not getting it right for every child
- Despite best efforts and significant investment, the problem continues to get worse
- If we keep doing what we're doing, we'll continue to get what we've got
- There is still opportunity to change that trajectory and **deliver better outcomes for families**

OBSERVATIONS FROM NEW YORK

More similarities than differences between jurisdictions

Models were delivering very promising results – with predicted outcomes

Target cohort virtually identical - multiple complexities within CP cohort

Highly motivated, skilled/trained, flexible and enthusiastic workforce

Clarity around goals, services and outcomes desired

Models are strengths based - deliberate, intentional and considered in delivery

Staff practiced in an accountable manner with regular supervisory feedback

Adherence to model fidelity is a performance measure and critical

Engagement of hard to reach families via assertive engagement skills






READINESS FOR IMPLEMENTATION

EVIDENCE BASED PROGRAMS

- Preparation



- ▼ Establish a cross functional implementation team to ensure all parts of the business are covered off and planned for.
- ▼ In collaboration with model purveyors readiness across the whole organisation was examined.
- ▼ Ensure Leadership buy in across the organisation.
- ▼ Set up evaluation and outcome measurement indicators to ensure the ability to determine success in the Victorian context.
- ▼ Stakeholder Engagement - establish implementation network with local government department creation of a strong feedback loop & referral pipeline.
- ▼ Identify possible barriers to implementation in consultation with model purveyors and design local adjustments to support models.

EVIDENCE BASED PROGRAMS

- Implementation



- ▼ Staff recruitment, induction and model training – families allocated immediately after training.
- ▼ Implementation of policies and procedures, development of consent forms, legal review.
- ▼ Continued with local implementation group to ensure barriers both perceived and real are addressed.
- ▼ Intermediary support on the ground for a month post launch and then moved to weekly calls with both developers and intermediary support.
- ▼ Further refinement of systems, processes, data collections to ensure continuous quality control.
- ▼ Safe Care – all educators accredited in May, Coaches in August and working towards being Trainers in November.
FFT-CW Supervisor has undertaken externship and is progressing to accreditation.

EVIDENCE BASED PROGRAMS

- Sustainability



- ▼ Ensuring the program continues with fidelity is a key component to sustainability.
- ▼ Integrated into everyday business, replicable with recurrent funding.
- ▼ Refining referral process and ensuring correct cohorts of families are receiving services at the right time.
- ▼ Identifying ongoing training needs of the teams.
- ▼ Demonstrating outcomes within local context.
- ▼ Ongoing coaching and booster sessions for staff with developers annually.

CULTURAL CONSIDERATIONS



The model integrity is maintained with a strong focus on matching culture in all areas of the programs.

WHAT WE HAVE LEARNT



▼ External Relationships	Establishing common understanding of programs; <i>and</i> defining referral pathways (inclusion and exclusions)
▼ Internal Governance	Dedicated commitment to implementation planning. Understanding impact across the organisation
▼ Recruitment	You need the right staff with qualifications but also personal attributes and characteristics.
▼ Infrastructure	Anticipating a workforce that operates remotely. Data collection capability to match monitoring and evaluation.
▼ Developer engagement	Critical to building confidence during preparation. Time zone challenges in maximising engagement
▼ Intermediary Support	Benefits of an informed and experienced third party. Differentiate between real and perceived barriers
