## **Information Sharing Schemes (DFFH)**

**About**: Developed for Child and Family Services professionals to understand how to share and request information under the schemes to promote the wellbeing and safety of children and assess and manage family violence risk.

DFFH have developed new Child and Family Violence Information Sharing Schemes eLearn modules. These training modules provide information about the three reforms, detail about the information sharing schemes, when to use FVISS and CISS and how the information sharing schemes and MARAM work together.

- Module 1 Information Sharing Schemes Essentials for Health and Community Professionals: provides an overview of information sharing; how to respond to and request information, understanding the importance of information sharing in promoting wellbeing and safety and protections and safeguards when sharing information.
- Module 2 Purpose and Requirements: to establish a deeper understanding of how and what information can be shared.
- Module 3 Consent and Privacy: to obtain a deeper understanding of the requirements for seeking
  consent, ethical practices, and requirements for Aboriginal and Torres Strait Islander people and
  diverse communities.

Delivery Mode: Online, Self-paced, 3 modules

The three modules each take approximately 20 minutes to complete.

- It is recommended that all professionals undertake this training.
- Funded Community Service Organisations and workforces.
- Workers who have already completed information scheme training or the currently available online 'Leaders' or 'Professionals (formerly Sharers)' modules are not required to complete the new DFFH funded agency specific eLearn modules unless they wish to refresh their skills and knowledge of the schemes.

**About**: DHHS, in partnership with the Centre for Excellence in Child and Family Welfare will be delivering MARAM training for practitioners in maternal and child health services who have roles that align with the Brief and Intermediate level of MARAM. This training covers:

- Effective Engagement: Foundational knowledge, Structured Professional Judgement Model, Child voice
- Identification of family violence risk: Intermediate risk assessment, risk levels, information sharing
- Prioritisation: Intermediate risk management, secondary consultation, safety planning
- Service delivery: Collaboration, information sharing, ongoing risk assessment and management, referral pathways.

**Delivery Mode:** This training is made up of four 2-hour modules.

#### This training is relevant for professionals who:

- Whose purpose of intervention is linked to family violence but not directly focused on family violence.
- Staff who engage with people in crisis situations, or at high risk of experiencing or using family violence

This training is for professionals who work in a specialist capacity across the integrated service system. This virtual training focuses on working with victim survivors.

**Delivery Mode:** Interactive, 3 x 2-hour virtual sessions, occurs over two days.

This training is relevant for professionals who: This training is only suitable for experienced family violence specialists (tier 1) who have extensive experience, and who have previously completed specialist CRAF training.

## **Family Violence Foundations (Safe and Equal)**

**About:** Family Violence Foundations will build your foundational knowledge to prevent, identify and respond to family violence and violence against women. This course provides a common starting point upon which professionals may seek to develop the skills needed to undertake their role in family violence prevention and response.

- Stream 1 Violence against women
  - Definitions and prevalence of violence against women; common attitudes, beliefs and myths that drive violence against women, gender inequality and violence against women; the gendered nature of violence.
- Stream 2 Family violence
  - o Definitions, dynamics and impacts of family violence, the indicators of family violence, referral pathways for diverse victim survivors and perpetrators.
- Stream 3 Intersectionality, cultural safety, and responsiveness
  - o Intersectionality and systemic discrimination, violence against Aboriginal women, Aboriginal family violence and cultural safety, cultural responsiveness for culturally and linguistically diverse communities.
- Stream 4 Family violence, children, and young people
  - The natures, impacts and indicators of family violence for children and young people, supporting children and young people's safety, legislative and statutory requirements.

Delivery Mode: Online, Self-paced, 16 modules across 4 streams



### This training is relevant for professionals who:

- Professionals who come into contact with adult and child victim survivors or perpetrators of family violence in the course of their work – including people working in health, justice, human services, and education.
- New workers in specialist family violence response services.
- Professionals who have a role to play in preventing violence before it occurs for example, primary
  prevention practitioners and professionals in education, local government, media, or recreational
  settings.
- Students considering a career in the family violence or primary prevention sectors.

- The MARAM framework including core principles, key responsibilities and the application of practice guidance and tools.
- The concept of alignment with the MARAM framework.
- Organisational implementation of the MARAM framework, through alignment of policy and procedures, partnership development and staff support and management.
- The implications, challenges and complexities of applying the MARAM framework, through the application of the four MARAM pillars.
- The application of an intersectional lens in the alignment process.
- Communicating and supporting the wider vision of the family violence reforms as a leader.

**Delivery Mode:** Interactive 2 x 2-and a half hour sessions, virtual

This training is relevant for professionals who: This training is suitable for organisational leaders, CEOs, Directors, or senior managers across all organisations/agencies prescribed under the MARAM.

• The training is pitched at a senior level to those who have decision making responsibilities leading the embedding of MARAM in the organisational context.

## **MARAM Collaborative Practice Training**

**About:** The MARAM Collaborative Practice training focuses on both collaborative practice and foundational aspects of MARAM that enable collaboration.

The training focuses on collaborative practice and the foundational aspects of MARAM. This module will enable practitioners to contribute to risk assessment and collaborate for ongoing risk assessment and management, through respectful and sensitive engagement with service users, information sharing, referral, and secondary consultation.

This training complements MARAM training delivered by DHHS, DVRCV and the CFECFW. This training does not provide the training for practitioners in working directly with families using the MARAM assessment and safety planning tools.

**Delivery Mode:** 1-day training (via Zoom or in-person)

This training is relevant for professionals who: Required training for all MARAM-prescribed workforces.

## Course in Identifying and Responding to Family Violence Risk (22510VIC)

**About:** The Course in Identifying and Responding to Family Violence Risk is designed to help community service workers provide an initial response to the family violence risk they encounter. This course covers:

- Foundational family violence knowledge
- MARAM responsibilities aligning with Screening and Identification (1, 2, 5, 6, 9, 10)

**Delivery Mode:** Delivery is online through registered training organisations (RTOs), including dual-sector universities and TAFEs. It includes a series webinars equivalent to 2 days and plus pre-reading and assessments.

This training is relevant to professionals who:

- People from across universal services (tier 4) who provide service to people but for whom family violence is not the core part of their job; and
- People who work with people in therapeutic and crisis services (tiers 2 and 3), who will be progressing
  on to develop skills in MARAM Brief and Intermediate

# Course in Intermediate Risk Assessment and Management of Family Violence Risk (22561VIC)

**About**: This course provides participants with the skills and knowledge to undertake intermediate risk assessment and management of family violence risk, in accordance with the requirements of Victoria's Family Violence Multi-Agency Risk Assessment and Management Framework (MARAM Framework). This course covers:

- VU22733 as per the course above (22510VIC).
  - o NOTE: people who complete the 22510VIC course will receive credit for this unit
- VU22988 which covers: MARAM responsibilities aligning with Brief and Intermediate (3, 4) including skills relating to adolescents using violence and perpetrators

**Delivery Mode:** Delivery is online through registered training organisations (RTOs), including dual-sector universities and TAFEs.

This training is relevant to professionals who: People who work with people in therapeutic and crisis (tiers 2 and 3) or universal services (tier 4) who have job roles that require them to undertake MARAM Brief and Intermediate responsibilities

This course is intended for individuals in core support or mainstream service roles and includes the foundational understanding of family violence and risk needed for further levels of specialisation.
